Declaration of Dative Tutorship

Instructions

General Instructions

Use the Declaration of Dative Tutorship form to select a person to take the office of tutorship to your minor children in the event of your death or your inability to look after them and their property. If either of these things were to happen, this document, which does not need to be notarized, would immediately come into effect, avoiding the need for a tutor to be approinted by the court.

IMPORTANT. The wishes of the **last parent** to die or become incapable of assuming the tutorship always apply.

When the father and mother die or become incapacitated simultaneously (following a road accident, for example) and they have selected different tutors, it is the court that decides.

Parents

Enter (in block letters if completed by hand) the names and contact information of both parents and specify if it is the declaration of the father or mother. Each parent (when both are living) makes their own declaration.

Minor children

Enter the names of all your children younger than 18 who are likely to be placed under the tutorship of the person you have appointed. If you do not have enough space, continue on another sheet of paper. You may also appoint a tutor for children yet to be born by checking the corresponding box. If you wish to appoint a different tutor for one of the children, complete a separate form for each tutor you wish to appoint.

Appointed individuals

The person you select must have reached maturity (or be fully emancipated). They may be Canadian or of another nationality, and reside in Canada or in another country. They must be able to exercise their civil rights and be in possession of all their mental faculties.

You may appoint one individual who will look after the person and property of the minor children OR

you may appoint a tutor who will look after the person and another tutor (or more than one) who will administer the property. The tutor to the property may be a legal person, for instance, a trust company. You may also choose a substitute for each appointed tutor, for whom the same criteria will apply. If you need more space, continue on another sheet of paper.
